Master of Science in Pharmaceutical Chemistry -2 Years PG Course

1. General Guidelines:

- (a) The Society/Trust must be registered and the Memorandum of Association (MOA) must have a clause of getting into education in the State of Himachal Pradesh.
- (b) The Members/Trustees of the Society or Trust should not be involved in any criminal or court case.
- (c) The Society/Trust must have adequate experience of running and managing educational institutions.
- (d) The Society/Trust must provide approved building plan from Competent Authority indicating permanent location of the building. The location must be easily accessible by public transport.
- (e) The Society/Trust must provide "No Objection Certificate" from the State Government for starting the applied course(s).
- (f) The land/building of the Institution must be registered in the name of the Society/Trust and in clear possession of the Society/Trust.

(g) Non-encumbrance, pollution clearance and land use certificate obtained in quitarely from the Competent Authorities must be submitted.

H.P. Technical University and should not be mortgaged to bank or other financial institution.

- The common facilities namely water, sewage, electricity, etc. must be available.
- (j) 70% construction of building must be available prior to inspection as per requirement of the 1st year so as to start classes at the beginning of relevant academic year.
- (k) The Society/Trust must furnish proof of financial strength how to provide complete infrastructure for the Institution and its smooth operation. The applicant should also demonstrate how shortfalls in funds, if any, for recurring expenditure would be met. Loan against fixed deposits is not permitted.

- The funds of the Society/Trust must be audited and the income tax clearance must be obtained. Audit report duly certified by Charted Accountant must be submitted to University on yearly basis.
- (m) The Society/Trust must fulfill all other conditions to start the Institution and for running the course(s) as laid down by the UGC norms, if any.
- The Society/Trust must facilitate accommodation and transportation of (n) students and staff to the institute.
- Principal/Director of the Institute must have been appointed/identified at (o) the time of filling the application for affiliation.
- Unit Size (for UG and PG Course) is 30 seats. (p)
