Terms & conditions:-

- (1) The term of the Chairman (Vice-Chancellor's Nominee) and Members of *ad-hoc* Board of Studies shall be two years which shall be ceased earlier, if regular Board of Studies is constituted or the concerned Chairman (Vice Chancellor's Nominee) ceases to be a teacher/employee of concerned University/Institutes.
- (2) The Chairman shall forward within a week's time to the Vice-Chancellor and the Faculty concerned all decisions and recommendations of Board.
- (3) Subject to overall control and supervision of the Academic Council, the duties and functions of the Board of Studies shall be as under:-
 - (a) To approve subject/disciplines and their courses of study for diplomas, bachelor degrees, master degrees and research degree programmes and the other requirements of various degrees.
 - (b) To recommend to the concerned programme of studies to the Technical University.
 - Courses of studies and appointment of examiners but excluding research degree.
 - Appointment of supervisors for research work.
 - Measures for the improvement of the standard of teaching.
 - To ensure that the curricula and syllabi of various courses offered by the teachers in the Departments are periodically reviewed and continuously revised and updated.
 - To perform such other functions as may be assigned to it by the Academic Council, Board of Governors or the Vice Chancellor.
- (4) In case the nominated Chairman is not present at any meeting the senior most members present shall act as the Chairman of the meeting.
- (5) The Board of Studies shall ordinarily meet at least twice a year and on such occasions as may be directed by the Vice Chancellor.
- (6) Other terms and conditions will be prescribed in the Statutes/Regulations of the University.
